TEMPORARY TRAFFIC CONTROL DEVICE

NOTICE UNDER SECTION 17 (3) ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Senior Sergeant First Class of Police, for and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 17 (3) of the Act.

I declare that the **Music in the Park** is a **'temporary purpose'** to which this section applies.

I direct that a **25km/h** temporary speed restriction will apply to the following roads between **2.0pm and 11.30pm on Saturday 8 February 2025**:

Within the City of West Torrens: -

- **Birdwood Terrace, North Plympton** from a point 15 metres north of Oval Terrace to the south-western end
- **McArthur Avenue, North Plympton** from Urrbrae Terrace for 15 metres south
- **McEwin Avenue, North Plympton** from Birdwood Terrace for 15 metres west
- **Laverick Road, North Plympton** from Birdwood Terrace for 15 metres west
- **Manfred Street, North Plympton** from Urrbrae Terrace for 15 metres south
- **Henry Street, North Plympton** from Urrbrae Terrace for 15 metres south
- **Urrbrae Terrace, North Plympton** between Birdwood Terrace and James Street
- **Mackay Avenue, North Plympton** from Birdwood Terrace for 15 metres west
- **Murdoch Avenue, North Plympton** from Birdwood Terrace for 15 metres west
- **McArthur Avenue, North Plympton** from Oval Terrace for 15 metres north
- **Oval Terrace, North Plympton** between Birdwood Terrace and James Street.

I hereby authorise **Altus Traffic**, its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of the speed zones.

I direct that the installation and removal of necessary and appropriate traffic control devices for the conduct of this event can only be performed by a person with work zone traffic management training.

All works to be undertaken must be done so in accordance with the **"SA Standards for Workzone Traffic Management"** (which calls up the **Austroads Guide to Temporary Traffic Management and AS1742.3**).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.
